

Bylaw No. 83

A BYLA OF THE VILLAGE OF CRAVEN, TO ESTABLISH THE MANNER  
OF COLLECTION OF TAXES FOR THE SAID VILLAGE.

-----

Whereas it is deemed expedient to encourage prompt payment of taxes;

Now, therefore, the Council of the Village of Craven, in the Province of Saskatchewan, enacts as follows:

1. Current tax levies shall be considered due on the First day of August in each year. Current tax notices of the Village of Craven shall be mailed to the respective property owners not later than the First day of August in each taxation year.

2. For prompt payment of current tax levies, the following discounts shall be allowed: -

(a) Payment received on or before the 31st day of August ----- 5%

(b) Payments received during the month of September - - - - - 4%

(c) Payments received during the month of October - - - - - 3%.

3. On the First day of January in each year, a penalty of 10 per cent shall be added to all taxes unpaid and outstanding at that date. The penalty shall form part of the taxes except that a discount for payment of the arrears of taxes and penalty, or a portion thereof calculated on the combined arrears and penalties so paid shall be allowed at the following rates:-

(a) Payments received during the month of January -- 5%

(b) Payments received during the month of February- 4%

(c) Payments received during the month of March - 3%

(d) Payments received during the month of April - 2%

(e) Payments received during the month of May - 1%

4. The discounts authorized under the provisions of Section (2) of this bylaw shall not apply to local improvement levies.

5. This bylaw shall come into force and effect from the 31st day of December, 1980.
