2. This Bylaw shall come into force and take effect on the final date of passing by Council.

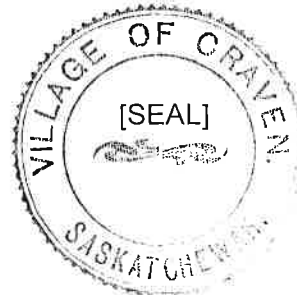
