## **CALL TO ORDER**

The meeting was called to order at 7:00 PM by Mayor Anderson.

## **MINUTES**

**02-05-25 Kozak/Hart** – That the Regular Meeting Minutes held on April 8, 2025 be approved as presented. CARRIED

Councillor Morin recused herself from the next item of business and left the room at 7:03 pm.

## **DELEGATION:**

1. Robert Wilson – Water

Robert attended the council meeting to discuss buying water for Country Thunder. Aquarius Water is contracted to haul potable water to the showers at the grounds this year. He is estimating he would need 17-20 loads at around 1800 gallons per load and would like to buy Craven's water for \$90 per load in a course of 3 days. It would take him an average of 25 minutes to fill an 1800 gallon load.

The risks would consist of hot weather arising from high water usage which would cause low pressure. If there was a potential fire or a well problem he agreed that he would shut down and go elsewhere. We always keep a close eye on the reservoir levels during Country Thunder weekend. He changed his offer to \$100 per 1800 gallon load. Council agreed that a contract will be made and further discussed at the next council meeting. Robert left the meeting at 7:20.

## Councillor Morin returned to the meeting room at 7:21 pm.

2. Richard Lipiec - update

Richard attended the council meeting to give an update on work as well as concerns that has been going on throughout the Village.

He discussed the concern of the CP Rail Derailment. Mayor Anderson said she received a call personally from CP Rail and this was considered a low risk derailment. CP Rail has committed to reconnect with a debrief in a few weeks when the investigations are complete.

With the drainage issue at the top of fraser avenue, Richard would like to use some reclaim and create a ridge on the edge of the road to keep the water moving down the street and past the properties.

The water consumption has been increasing a lot in the last few days with the hot weather. A post should be reminded to residents on how to reduce water usages when watering the lawns. Especially not to

water in the heat of the day. Richard keeps a close eye on the reservoir. It holds 65,000 gallons and he doesn't let it get below 20,000. We will be increasing the minimum during Country Thunder.

The EPO is not concerned with hydrocarbons that was previously reported as low from Wyatt Engineering. We will be discussing this further with Wyatt at the next meeting.

Top soil is needed at the new park. The grass is struggling to grow. Estimated 1 to 2 yards needed or more. The Elks has a bag of grass seed that we can use.

Richard said he would fix the sidewalk by the fire hall when he replaces the 2 fire hydrants this summer. Council thanked him for the updates and he left the meeting at 7:47 pm.
